Land options for a new library and how to proceed

It was agreed that the library in the park was most desirable because of cost and because the land is served by sewer and water.

The school land is second in desirability, but at considerably more cost, due to the cost of the land itself, a house on the land, and not served by sewer and water.

The board agreed that it would be good to keep the conversation about the park land open, in spite of some initial negative feedback received at the Town meeting.

The board agreed that Dianne would go to the Town meeting the next day and speak during public comment, providing more information to the Council and those present, explaining why a library in the park was a good idea, and address some of the concerns brought up at the Town council meeting. The board worked on a statement to be read by Dianne at the Town meeting.

Denise mentioned that Bitterroot Library is next to a small park and the community loves it. She said a park and library make perfect partners. Denise said Bitterroot Library is able to have summer programming outdoors on the lawn that people enjoy, including Animal Wonders. Dianne said she would add that information to her statement and asked Denise to write it up and send to her after the meeting.
